## HCMS Snowsports Program Participation Agreement

I give my child, (please print legibly) \_\_\_\_\_, permission to participate in the 2018 HCMS Snowsports Program.

**Only students who are passing all of their classes as of the end of school on December 22, 2017 are eligible to sign up for the program.**

I understand and agree to the following:

1. My child's grades will be reviewed each Tuesday during the duration of the program. If my child is failing any of his or her classes at that time, then he or she will be expected to be in classes on the following Friday. He or she will not be excused from classes to participate in the program.
2. I understand that it is my child's responsibility to get from teachers any schoolwork he or she will miss each Friday and to do that work in a timely fashion. Participation in the program does not exclude students from doing the coursework that is done on the days they miss classes.
3. My child's behavior record will be reviewed each Tuesday during the duration of the program. If my child has been referred to the office more than once during the preceding week of school or has been suspended in or out of school, then he or she will be expected to be in classes on the following Tuesday. He or she will not be excused from classes to participate in the program.
4. I understand that refunds are not available if my child is deemed ineligible to go for academic or behavioral reasons.
5. I understand that my child is expected to stay with his or her instructional

group and follow the instructor's directions while at the mountain.

6. I understand that my child will be under the supervision of a school representative and parent chaperones during each visit to the mountain and that my child will need to follow the directions of these adults.

7. I understand that my child will be provided transportation each week by bus. I understand that I can make alternative transportation arrangements for my child and that I will communicate those to the school prior to leaving for the site. No phone calls or notes will be accepted at the sites.

8. I understand that my child must be appropriately dressed for each visit to the mountain and that if my child is not appropriately dressed for the weather, then he or she may be asked to stay in the lodge.
